#### **CEO REPORT**

We will encourage members who are having to drop their arrangements temporarily due to reduced income to remain as <u>Associate</u> Members.

In numerous movies and TV shows you have undoubtedly seen well-funded organizations with deep security. To enter the building, you may have to show ID, have your fingerprints checked or your retina scanned. You will be captured on video at all times. Access to sensitive areas is blocked by thick metal walls, security guards, and automated lasers. (Somehow, despite all that security, someone always breaks in.) A few places in the real world have security that comes close to these dramatic constructs.

# HOW TO BECOME AN ALCOR MEMBER

Alcor is not one of those places. We value patient security very highly. But we don't have a multi-billion dollar budget with which to hire a large and highly-trained security team or to buy expensive and sophisticated security systems. Until we grow enough to make those things possible, it's pointless to apply perfectionist standards to Alcor's security. What we can do is continually look out for significant weaknesses that can be remedied affordably.

Becoming an Alcor member is easy and surprisingly affordable, if you are in good health and eligible for life insurance, which will pay for your cryopreservation. One area that has been something of a weak spot in terms of unauthorized entry into the building by persons of destructive intent has been the skylight in the area behind the front offices. Although the skylight covering is not easy to break through, it could be done quickly enough by persons who came equipped for the job. We have now eliminated that weak spot, although potential intruders from above would not know that until they had managed to get through the existing skylight cover. Steve Graber is also completing the installation of a vastly more useful video surveillance system that enables us to see both inside and outside the building.

If you should be in a position to identify a significant weakness in our security (one that is not exorbitantly expensive to remedy), please do not publicly post that information - as one member did. Doing so can only help potential attackers. If you have a genuine contribution to make to

#### READINESS AND TRANSPORT REPORT

#### **Patient Lift Assist**

The patient lift assist is about 95% complete with only cosmetic items remaining. It is fully functional in its current condition. Steve Graber completed design and fabrication of the patient lifting bar and then tested the lifter system by lifting five 20 liter bladders filled with water in our standard 'mega-mover'. One hundred liters of water is equal to 220 lbs and the hoist managed this weight without breaking a sweat. At that weight the entire laden hoist can be easily maneuvered and positioned by one person. Future lifting tests will be performed with additional weight.

The lifting tests were performed from the floor to the ice bath, from the ice bath to the OR table, and then back to the ice bath. Each time, the hydraulic piston was actuated to lift and lower the load. By rotating the load spreader bar 90 degrees and holding it parallel to the hoist arm Steve was able (without help) to roll the entire laden assembly through a laboratory obstacle course and placed the water bladders into the new surgical/cooldown table. The wheel motion and steering capability is smooth and easy to perform even with one person. During an actual case we would not see a need to perform such movement throughout the building, but it's good to do such a test if just to assess the capabilities of the Patient Lifter machine.

The photo shows the mega-mover attached to the hoist arm by 3 chains, spreading the load evenly across the bar such that our simulated patient load is actually quite level.

A major benefit of this design, aside from the obvious reduction in work related injuries due to manual lifting, is that once the patient has been lifted out of the ice bath we can place a thin plastic sheet underneath the entire mega-mover and hopefully eliminate any water spills on the OR floor during the transfer to the OR table phase.

#### **Membership Statistics**

**April Member Stat Chart** 

Alcor had 963 members on its Emergency Responsibility List. Five memberships were approved during the month of March, one membership was reinstated, one membership was cancelled. There were no members cryopreserved. Overall, there was a net gain of four members in March.

#### **Applicant Statistics**

Alcor had 43 applicants for membership. Five new applicants were added, six applicants were converted to members and two applicants were cancelled resulting in no net loss of three applicants in March.

#### **Information Packet Statistics**

Alcor received 97 info pack requests in March. Eighteen were handed out during facility tours or from special requests. The average total of 94 info packs sent per month in 2012 compares to 104 in 2011. The full <a href="Information Packet">Information Packet</a> is now available online.
