### CEO BOARD REPORT FROM THE ANNUAL MEETING SEPTEMBER 2018

Predictably, the unpredictable has happened again! On the first day of the Strategic Meeting, we were notified of a



probable impending cryopreservation case. This will be the eighth this year. In order to complete a board report, I'm not necessarily delving into all the most important recent or year-long developments. Apart from the time that would require, most of those involve issues that are private (especially a major legal issue), at least for now.

#### **Recent Cases**

We have had five cases leading to a cryopreservation over the last four months. You will find three new case

summaries on the website here bringing them up to date except for the latest case still in cool down as this issue is finalized):

### **Membership Trends**

Growth in (full, cryopreservation) members continues to accelerate gradually. We ended 2017 with 1,143 members. At the end of September 2018 we were up to 1,214. That's a gain of 71. Annualized, this represents a growth rate of 8.3% -- the fastest since 2005 (right before we raised cryopreservation minimums). If this can be sustained - which cannot be guaranteed in part because we may have a higher number of cancellations - it would be the fastest growth rate since 2005, and the largest total net gain in members ever. I joined Alcor in 1986. We will have added more members during this year than all the members of Alcor in that year. (As a self-indulgent but related side-note: I was finalized as a member 32 years ago on (Sept 14).

# New Jobs and Revised Job Descriptions and Responsibilities

Congratulations to Marji Klima on her well-deserved promotion to Executive Administrator. Now that the Strategic Meeting is over and our new MRD has been hired, we look forward to hiring a Front Office Assistant to free up Marji's considerable talents for higher-value activities.

#### **IT-Enhanced Processes**

Alcor is now making good use of Slack, a cloud-based set of proprietary team collaboration tools and services. This has quickly proven to be especially useful in keeping multiple participants (both within Alcor and with contractors and consultants) on the same page. After a bit of a false start (with an inappropriate version of the software), Alcor has now made the transition from locally-based (and no longer supported or updated) QuickBooks to QuickBooks Enterprise Cloud. We have plenty of ideas for further improvements in organizational efficiency and effectiveness (especially relating to keeping members happy) but I will hold off on reporting

further for now.

#### **Outreach**

Thanks to Barry Aarons, I was able to give a tour of Alcor to Tim Brown, the President & CEO of the Donor Network of Arizona. On August 24, again arranged by Barry, I and several other Alcor staff met with Melanie Rouse, Maricopa County's Chief Medicolegal Death Investigator. We discussed Alcor's patient process, needs, and protocols. Additionally, the group opened lines of communication with the County regarding special circumstances in which alternative actions for patient preservation are necessary (e.g. when the County requires an autopsy.) Ms. Rouse agreed to take a tour of Alcor in the near future.

On July 25, I spent a couple of hours giving a tour and talking with 15 students from Chandler Gilbert Community College, brought by professor Amanda Price for a class on "Research Based Approach to Science Fiction".

#### **Recent Media**

Alcor Announces Search for a Chief Operating Officer

The Alcor Board of Directors and President/
CEO are undertaking a search for a Chief Operating Officer
(COO). Initially, the search will only be among current Alcor
members. The COO will be responsible for organizing,
staffing, and managing personnel to carry out operations of
the organization including patient maintenance,
standby/stabilization/transport, cryopreservations, finance &
accounting, membership, updating member documentation,

and information technology. As an Alcor Officer the COO will set yearly goals with the Alcor Board of Directors and report to the Board on accomplishments and milestones. On a day-to-day basis, the COO will work closely with Max More, Alcor's President and CEO.

Creation of this new position recognizes the accelerating growth of Alcor and broader responsibilities of senior management. It represents a major step forward in further professionalizing our structure, allowing, for example, the President/CEO to focus his attention on areas such as outreach, membership recruiting, fundraising, the Research Committee, authorizing case reports, and legal matters. As President/CEO, Max will remain the spokesperson for Alcor with regard to the media, outside authorities, at conferences, in public forums, etc.

The COO position will include industry competitive compensation, benefits, and an allowance for relocation to the Scottsdale area if necessary. # Revised LN2 Fill Manifold System, Liquid Level Monitoring Update

A major Patient Care Bay expansion project this past year required significant changes to the layout of the Dewars, and subsequent relocation of the liquid level monitoring wiring and fill system piping. This change required major plumbing work. Additionally, I modified the Liquid level monitoring system code to accommodate up to 10 more Dewars.

### **Variable Speed High-Capacity Hoist Upgrade**

Part of our recent PCB expansion project was the addition of an enclosed hoist 'penthouse' which replaced a set of large roofmounted doors and an exterior gantry. Having the hoists inside and available for immediate use at any time is a major improvement. To further improve our hoist capabilities, I purchased and installed a variable speed high-capacity hoist. In this photo you can see the cradle rig that I devised to lift this very heavy hoist with a



forklift 25 feet up and through the ceiling opening.

### **Variable Speed Hoist for Patient Transfers**

We are now using this 500 lb. capacity rapid hoist system to reduce our patient transfer time from O.R. into the initial cooldown box, as well as for any other heavy lifting in the P.C.B. under 12'. It has also proven particularly handy when receiving patients on Dry Ice. Patient transfers into long-term storage Dewars still continue to be performed using the main roof-mounted hoists (referenced below).




### **Secondary Cooldown System**

This LabVIEW based cooldown system is a clone of the main cooldown system located in the Patient Care Bay. The system is self-contained, mounted in a rolling cart base and can be programmed to perform any type of cooldown required. It is mainly to be used in the case of two cooldowns being required either simultaneously or overlapping.



## Chemical Storage, Mixing and Washdown Station

Mixing of perfusates used to be done in our O.R. but now it has a dedicated space in the building. This room now houses the chemical disperser/mixer that used to be in the O.R. where we previously mixed perfusate and washout solutions. It features a high flow extraction fan, an emergency eye wash, shower deluge system, chemical storage cabinets, wire drying racks, and a chemical mixing station.

In addition to a Certified Public Manager certification from Arizona State University, Chris was the first company officer from his fire department to be accepted to and graduate from the Executive Fire Officer Program at the National Fire Academy; a four-year management and leadership course that examines how to exercise leadership when dealing with difficult or unique community challenges.

Chris has authored several published research papers, print and electronic magazine articles, as well as two novels. He lives in Peoria, AZ with his wife, Karen, and their two furbabies, Clark and Ellen.

#### **Cryonics Practices Now Legal in B.C.**

I have an exciting update about Lifespan's

legal activism that has been ongoing since 2015. Below is a short summary of our case and its resolution. I have attached the letter from Consumer Protection BC.

The Lifespan Society was scheduled to go to court in June to challenge the constitutionality of s.14 of the Cremation, Interment, and Funeral Services Act (CIFSA), which prohibits the sale of cryonics arrangements sold on the expectation of resuscitation of human remains. The litigation had been making its way around numerous obstacles since 2015, including the government's repeated arguments that what Lifespan was seeking to offer prospective consumers in B.C. did not in fact fall within range of what s.14 prohibits. The problem with this was the government could not make any assurance that it wouldn't simply change its mind in the future after considerable expense and planning was expended on Lifespan's part. Thus, in order to get clarification on s.14, the Lifespan Society filed a revised notice of civil claim in 2016 which included a signed contract for cryonics services between the Lifespan Society, and member Keegan Macintosh.

Our court case centered around what exactly an "expectation" of resuscitation" means in the context of s.14, and how broadly or narrowly it ought to be interpreted. Being unique in Canada and throughout the world, s.14 had never been tried before, thus there was essentially no guidance as to how exactly the law would be interpreted, leading to substantial uncertainty and anxiety on the part of B.C. cryonicists. Previous attempts at getting clarification had only gotten so far as receiving a letter from Consumer Protection B.C. which appeared to say that the sale of cryonics arrangements was prohibited within the province, but that arrangements with out-of-province providers were permitted. It was not at all clear whether organizations located in the province could offer standby and stabilization services (of particular interest to members of the Cryonics Institute, which does not provide these services). Also, some funeral directors approached by local cryonicists had expressed concern about getting involved in potentially prohibited activities. Thus, since 2012, Lifespan Society and its committed volunteer board of directors, and especially current President Carrie Wong and former Executive Director Keegan Macintosh had been slowly but surely moving this case along to gain much needed certainty around s.14, and hopefully persuade the court to see that it violated British Columbians rights under the Charter to life, liberty, and security of the person.

However, the week before the trial was to be heard in June, the government approached Lifespan's lawyers, Jason Gratl and Toby Rauch-Davis, with a peace offering in the form of a letter from Consumer Protection BC (the regulatory body tasked with enforcing s.14). The letter lays out the regulator's position that it does not view Lifespan's contract with Macintosh as being within its public interest mandate to investigate and prosecute for violating s.14. The letter is careful to note that a major part of its opinion is based on the apparent level of knowledge and understanding that Macintosh possesses about the science behind cryonics, and

its prospects for success. Another important part of the regulator's current position on the matter is that for the moment only a very small market in B.C. is interested in cryonics, and there is no evidence that it is being targeted at vulnerable persons. Following the recommendation of our lawyers, we have decided to accept this comfort letter and not pursue further legal action since Consumer BC has no interest in litigating against Lifespan's current cryonics arrangements and activities. Provided that future contracts entered into between Lifespan and its members are under similar circumstances -that is, ensuring that they are fully apprised of and clearly understand the science informing the practice -we do not foresee regulator interference in local cryonics cases.

We are pleased with this outcome, and applaud the province for (eventually) taking the reasonable approach of providing guidance on whether s.14 would be applied to responsible cryonics practices like those we aim to provide for B.C. cryonicists. We maintain that the practice of cryonics is a protected exercise of our Charter rights to life, liberty, and security of the person, but also one that can be reasonably regulated-as with both the funeral and health services industries-to ensure that is not being practiced in a way that is harmful or misleading to consumers. This is a big step forward in the ability for British Columbians to confidently enter into cryonics arrangements with both local and out-of-province cryonics service providers.

#### **Cryonics UK Wins Appeal to Retain Charity Status**

This journey began in the summer of 2016 when Cryonics UK was approached on behalf of a teenager with terminal cancer who wished to be cryopreserved. Several obstacles stood in her way, any one of which would have stopped most people in their tracks. However, she was unusually determined and won a High Court judgment to ensure that her wishes could be followed.

The case brought immense media attention and became the lead story around the globe upon release in November 2016. Coverage was largely positive with a scattering of negativity in the gutter press. This prompted a single complaint to the charity regulator about Cryonics UK's charity status.

The Charity Commission made inquiries about Cryonics UK's finances and operations lasting almost a year, finally announcing that CUK would be removed from the charity register as the Commission did not accept that 'the promotion and facilitation of cryonics and cryopreservation' was a charitable activity.

Cryonics UK could certainly operate without being a charity and received minimal tax benefits from its charity status. However, the loss of charity status produced a negative

message. It was therefore decided not to take this regulatory action lying down. The motivation was to stand up for the field of cryonics as a priority and hopefully retain CUK's individual charity registration along the way. There was always the possibility that cryonics could be deemed generally to be a charitable pursuit but that a technicality of CUK's operating model could still result in removal from the register.

An appeal against the Charity Commission's decision was filed with the court in December 2017. There followed formal exchanges of statements of each party's position and arguments, preparation of witness statements, compilation of scientific references and assessment of previous potentially relevant judgments. The intense workload continued right up to the hearing which took place over two days in July 2018.

Cryonics UK's appeal was handled by two part time volunteers. If this had been carried out by even the most basically qualified legal professionals, CUK's costs would have likely been a six figure sum and consequently prohibitive.

The obvious question that the public seem to be asking is 'How did you win?' So if you're also wondering this, here's the legal stuff:


