CEO Update

Are life extension and especially cryonics doomed to remain the province of a tiny minority of people? Changing responses to surveys in recent years encourage me. As Alcor member Reason reports: "However, in the last few years, things have apparently started to change. In 2015, in a study by Donner et al, it was found that given perfect mental and physical health, 797 out of 1000 participants wanted to live to 120 or longer; over half of these 797 people desired unlimited lifespans (around 40% of all participants). A new study by YouGov shows even more impressive results."

Among those results: Out of 1200 participants, one in five (19%) people agreed with the statement "I want to live forever" without any promises related to perfect health. 42% of the participants chose "I want to live longer than a normal lifespan, but not forever", while 23% said, "I don't want to live longer than a normal lifespan." Support for radical life extension was more supported by young people (24%) than by people over 55 (13%).

19% of people agreed with the statement "I want to live forever." A plurality (42%) chose "I want to live

longer than a normal lifespan, but not forever". And this from a randomly-select group of people. Few of them are likely to be regularly exposed to news about aging and longevity research. Compared to this 60%+ positive response, the 2013 Pew Research study found that only 38% of the participants expressed the desire to undergo medical treatments to slow aging and live to be 120 or more.

In commenting on this survey, Elena Milova wrote in "The American Public Increasingly Desires Life Extension": Interestingly, when asked about their preferred way to dispose of their body after death, 3% of people (that is, about 36 people overall) named cryonics! According to another analysis, 14% of Britons are confident that at least some of those who have been frozen will successfully be revived, while another 16% are unsure one way or the other. Among those in the group characterized as "Tech Disciples", 23% said they would be cryopreserved if money were no object.

From the MRD Desk

Hello and welcome to the inaugural issue of my monthly column. As your Medical Response

Director, I have the responsibility of ensuring our members have a smooth transition from member to patient. I cannot, however, do that without your help. This column will highlight some of those areas that have been identified during case debriefs as corrective actions our members and their families can take to assist me in ensuring a seamless transition. I will also use this column to address any issues or concerns our members may have as well as answer any questions.

One concern that is easily rectified is your documentation. As a member, you have made full legal and financial arrangements for cryopreservation with Alcor. While that is one major step in the documentation process, there are several other critical steps you need to take. One of those steps is ensuring your family, friends, and medical professionals are aware of your desire for cryopreservation. There will come a time when you are not able to speak on your own behalf and those around you (doctors, nurses, paramedics, etc.) will have to rely on your previously established paperwork in order to ensure Alcor is notified promptly.

Your paperwork should include an undated HIPAA form, a Durable Medical Power of Attorney (DMPOA) establishing who can speak on your behalf in the event you cannot speak for yourself, and a letter to your primary care physician outlining your desire for cryopreservation. While we certainly advocate wearing your pendant and bracelet identifying you as an Alcor member, you should not rely solely on that single form of identification to alert us that you need Alcor's response team.

One relatively inexpensive way to ensure your paperwork is up-to-date and available when needed is by utilizing a company that will digitally store your cryo docs. There are several companies such as Everplan, LifeSite, AboutOne, and Raymond James wealth management that offer an Everplan. These companies offer an easy-to-access, **secure digital archive** of everything you need throughout your life and that your loved ones might need should something happen to you. Through these sites, you can store all the vital documentation mentioned previously in one easy to access site as well as name your beneficiaries. Your beneficiary is an important person in your life whom you trust enough to provide access to some or all of your paperwork.

It is in your best interest to ensure your vital documentation is in place, up-to-date, and secure for when your loved ones need it.

The Bitcoiners Who Want to Defeat Death by Julia Herbst, Breakermag

An ardent futurist, Finney arranged to have his body cryopreserved by Alcor after his death. Like a number of their peers, Merkle and Finney shared deep interest in both cryptography and cryonics. But their connection goes deeper. Their audacious techno-utopianism can be traced back to an astoundingly optimistic group founded in the 1990s called the Extropians. The group was cofounded by current Alcor CEO Max More, an early cryonics obsessive so committed to living forever he kept a heart-lung resuscitator in his college dorm room in case of emergency. A true believer in the cryonics cause, More wrote to his Extropian brother Finney, on the day of his passing: "Hal, I know I speak for many when I say that I look forward to speaking to you again sometime in the future and to throwing a party in honor of your revival."

ALCOR FUNDS COMPREHENSIVE CRYONICS CASE META-ANALYSIS

The Alcor Hal Finney Cryonics Research Fund has awarded Advanced Neural Biosciences a three-year grant (2019-2021) to conduct a comprehensive meta-analysis of all Alcor cryopreservation cases. The project will consist of three phases: (1) The creation of a comprehensive case database, culminating in a preliminary meta-analysis to establish case trends and patterns. (2) The development of a quantitative metric (or series of metrics) that will allow Alcor to determine the quality of a case (3) Experimental research to model typical and unusual Alcor case scenarios and alternative protocols. This 3-year project will be completed with a final comprehensive meta-analysis and a set of recommendations. An important component of this project will be the integration and review of brain scans of all existing Alcor patients utilizing Alcor's new in-house CT scanner (also funded by the Hal Finney Cryonics

Research Fund).
